Draft terms of reference for an environmental impact statement (EIS) – Proposed Galalar Silica Sand Project

DIATREME RESOURCES LIMITED (Diatreme) proposes to develop the Galalar Silica Sand Project. The proposed project would be located at Cape Bedford, 20 kilometres north of Cooktown and 20 km east of Hope Vale in eastern Cape York. The project site falls within EPM 17795 (approximately 486 km²) on MLA 100235 (approximately 525 ha). Maps of the proposed project are available in the Initial Advice Statement on the Queensland Government website at www.qld.gov.au (search for Galalar EIS).

The project proposes a new open-cut silica sand mine with onsite washing, gravity separation and stockpiling of the product. Up to 950,000 tonnes per annum (tpa) of silica sand would be mined, producing up to an estimated 750,000 tpa of low iron silica. The proposed mine life is 15 years.

The product would be transported via truck and then barged to a transshipping location for export to overseas markets. Two options for barge loading and transfer facilities are being considered, at nearby Nob Point or Cooktown via the Endeavour River. Both will require construction of barge loading infrastructure and for Nob Point, an access road from the mine. Possible transshipping locations have been identified off Nob Point or within the Port of Cape Flattery port limits for the Nob Point export option or within or just beyond the Port of Cooktown port limits for the Cooktown export option.

On 14 January 2020 Diatreme submitted a voluntary EIS application, which was approved by the Department of Environment and Science (the department) on 5 March 2020.

The project is a controlled action (EPBC/2020/8626) under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The controlling provisions are sections 12 and 15A (world heritage properties), sections 15B and 15C (national heritage places), sections 18 and 18A (listed threatened species and communities), sections 20 and 20A (listed migratory species), sections 23 and 24A (a commonwealth marine area), sections 24B and 24C (Great Barrier Reef marine park) of the EPBC Act. The EIS process will assess potential impacts of the project on the controlling provisions consistent with the bilateral agreement (section 45 of the EPBC Act) between the Commonwealth and Queensland governments for the purposes of the Commonwealth Government's assessment under part 8 of the EPBC Act.

Diatreme submitted the draft terms of reference (TOR) for an EIS for the proposal to the department on 3 July 2020.
