## **Exchange of Land Application**

### Land Act 1994

#### Requirements

- 1. This application is for exchange of State land.
- 2. Please read the respective <u>Purchasing, exchanging or allocating state land guide</u>, which includes application restrictions.
- 3. Payment of the prescribed <u>Application fee</u> per title reference. A refund of application fees will not be given. Details of fees are available on the <u>Department of Resources website</u> at <https://www.resources.qld.gov.au> or contact your nearest <u>business centre</u> or call 13 QGOV 13 74 68.
- 4. **Part A online form:** <u>Contact and land details</u> or Part A <u>Part A L00 Contact and land Details (PDF)</u> must be completed and submitted with your application.
- 5. Any additional information to support the application.
- 6. For your application to be processed, all parts of this application form must be completed and accurately, otherwise your application may be returned to you to complete or refused.

#### Important information

- 7. You are strongly encouraged to arrange a pre-lodgement meeting with us before you apply to ensure you have the information you need to apply correctly. You can do this by contacting your nearest business centre.
- 8. Your application will be assessed against requirements under the <u>Land Act 1994</u> <a href="https://www.legislation.qld.gov.au/">https://www.legislation.qld.gov.au/</a> to determine the most appropriate use and tenure.
- 9. If an application is approved, the written offer sets out various conditions such as:
  - payment of any difference in the land valuations, including GST
  - payment of stamp duty.
  - lodgement of a plan of survey, if needed.
  - payment of all regulatory fees and charges.
- 10. Information on this form, and any attachments, is being collected to process and assess your application under section 18 of the <u>Land Act 1994</u>. If required, we may need to consult with third parties such as relevant local or state agencies and adjoining property owners. Details provided to third parties will generally be limited to type of application, area applied for and intended use. Your personal information will not otherwise be disclosed unless authorised or required by law.
- 11. Please note that we may wish to contact you to seek your views on our service, to advise you of any legislative changes that might affect you or to seek your participation in surveys or programs relevant to your application type. Any participation will be voluntary and you may email <u>stateland@resources.qld.gov.au</u> if you do not wish for the department to contact you.
- 12. The department may also compile or analyse statistics and conduct research. Any publication of findings will not involve the publication of identifying personal information.
