1 Introduction to Macropods Online

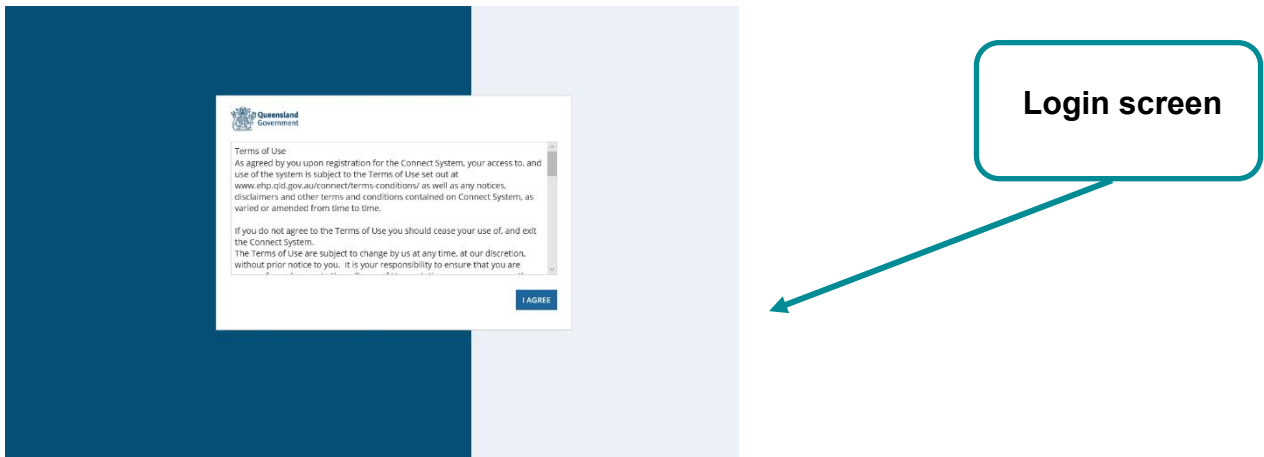
The Department of the Environment, Tourism, Science and Innovation has a user-friendly digital platform for managing macropod services allowing macropod licence holders to apply for licences, pay fees, and order tags.

The digital return book feature on Macropods Online makes it easier for harvesters and dealers to comply with their record keeping obligations. And submitting returns is also faster and easier allowing users to view and complete their tasks online as simple transactions.

You must request permission to amend a non-nil return you have previously submitted. If your request is accepted, you will be able to make changes to the return line items and re-submit that return.

Go to **MY RECORDS > SUBMITTED RETURNS**
