


 The PAH can provide help, information and legal referrals to all patients including pre- and posttransplant inpatients and outpatients.

# Princess Alexandra Hospital is a safe place

- PAH is a safe place and can help PAH patients or families affected by domestic, family or intimate partner violence abuse.
- Many people who seek treatment for medical conditions, have experienced abuse and/or violence either recently or sometime in the past.
- Some patients have received support and help before, either at the PAH or another external service, whilst others have never shared past traumatic events and silently carry these with them.







# Princess Alexandra Hospital helps people affected by abuse



- Staff can help patients get medical, personal, family and legal support. Ask your treating team for help
- The Women's Legal Service is available by appointment at PAH for women who have experienced domestic violence or who are seeking legal advice around family law and child protection. Contact a PAH social worker for information and referral.
